

TERMS OF TRADE

By signing this credit application the customer (“you” or “your”) agrees with Express Couriers Limited (“we”, “us” or “our”) as follows:

“products” means courier and freight products or equipment (customised or otherwise) provided to you by us.

“PPSA” means the Personal Property Securities Act 1999. Any terms and expressions that are defined in the PPSA shall have the same meaning when used in these terms.

“Terms and Conditions” means the Express Couriers Limited Terms and Conditions as set out at www.expresscouriers.co.nz.

1. You accept, and agree to comply with the Terms and Conditions.
2. You will pay the full amount of your account for transactions in any month by the 20th of the month following the invoice date. No reduction shall be made by way of set-off in respect of any claims against us or for any other reason.
3. We may charge you interest on any unpaid amount at our overnight overdraft daily interest rate charged by our principal bankers, calculated daily and compounding monthly from the due date until the date you pay the unpaid amount.
4. Failure to comply with any of these terms may result in closure of your account. We reserve the right to alter and/or withdraw credit facilities at any time.
5. You grant us a security interest for all of your obligations to us.
6. In addition to any other rights that we may have at law (including under any statute), we or our agent may enter any land or building owned, occupied or used by you, to search for and re-take possession of any products provided to you if:
 - you do not comply with any of these terms, the terms of Carriage of Goods Act 1979, our Terms and Conditions, or any other agreement between us; or
 - you are adjudged bankrupt, liquidated or dissolved, or an administrator, a receiver or similar officer is appointed.
7. In the event that we are required to undertake action for recovery of outstanding debts from you then you will pay us the reasonable costs and disbursements incurred by us (including on a solicitor client basis) of any such enforcement.

Personal Property Securities Act 1999

8. You agree that sections 114(1)(a), 117(1)(c), 133 and 134 of the PPSA shall not apply on the enforcement by us of any security interest created or provided for by these terms to which Part 9 of the PPSA applies. You waive any rights you may have under sections 116, 119, 120(2), 121, 125, 129 and 131 of the PPSA on such enforcement.
9. You waive any right you have to receive from us a copy of any financing statement, financing change statement or verification statement that is registered, issued, or received at any time in relation to these terms.
10. If you change your name, ownership or directorship, you must give us 14 days’ written notice of such change.
11. Any payment received from you may be applied by us to all or part of the amount owing for any products provided to you as we see fit, irrespective of whether that payment is intended by you to be for particular products or in respect of a particular invoice.
12. You will pay all of our costs and expenses in relation to compliance with any demand given by you under section 162 of the PPSA, or in relation to any application for, or the obtaining of, a court order to maintain any registration in respect of any of the security interests created by these terms and the serving of any such court order on you or the Registrar of Personal Property Securities.

13. You consent to us collecting, using and holding general credit information about you, and to disclosing that information to any third party (including any credit reporter or credit enforcement agency which may provide that information to third parties from time to time) in connection with credit management and control purposes. You understand that we will credit check you and you agree that we may collect information from any person who can provide us with information relevant to us. You can access and request correction of any of the personal information we hold about you by writing to us.
